Basis for Black type

Horses appear in **UPPER CASE BOLD TYPE** if they have a record of 2:00 or faster, earnings of \$100,000 or greater, or a win in an added money event.

Horses appear in **Mixed Case Bold Type** if they have not achieved any of the items listed above, but have finished either second or third in an added money event.

CHAMPIONS CENTER BIO SAFETY GUIDELINES

- All persons must enter the Champions Center via Laybourne Rd. entrance also marked as "Gate D"
- Trailers/campers must be parked with doors facing AWAY from each other, trailers/campers parked with doors facing each other will be asked to move
- Trailers/campers must be parked at least 6 feet apart
- Everyone is strongly encouraged to wear a mask
- Exhibitors are required to practice social distancing (at least 6 feet) throughout the entire event, in the facility AND in the camping area
- Large gatherings of 10 or more people will not be allowed in camping area OR stall aisles

- Traffic in the show office will be limited to show personnel only. Entries will be taken through the front window of the show office
- Dependent on weather, all overhead doors in the facility will remain open at all times to ensure ventilation and air flow
- Each individual show may provide their own list of guidelines and we ask everyone to comply with those as well
